# **Project Update**

- New dishwashers were installed in the villas. The washers have stainless steel interiors and are much quieter and easier to operate than the previous model.
- In October 2018, we continued to improve the summer pool experience with the addition of six new canopy umbrellas. These umbrellas surround the new pool that was built and opened in May 2018. Below is a picture of the finished product. We are very excited to get your feedback on the improvements.
- Our entertainment platform is currently being upgraded to World Cinema. This
