Two (2) votes for Candidate A (he writes in " 2 " in the appropriate space), two (2) votes for Candidate B (he writes in " 2 " in the appropriate space), two (2) votes for Candidate C (he writes in " 2 " in the appropriate space), and zero (0) votes for Candidate D (he writes in " 0 " in the appropriate space).

## Example (Every Other Year Owner):

Ms. Jones owns one (1) week every other year and is therefore entitled to one (1.5) vote (number of weeks owned [0.5], multiplied by number of Board Members to be elected [3]). She may cast her votes in any point five (0.5) increment she desires. She may choose to split her votes between three (3) candidates. She may complete her Ballot as seen below. Point five ( 0.5 ) votes for Candidate A (she writes " 0.5 " in the appropriate space), point five ( 0.5 ) votes for Candidate B (she writes " 0.5 " in the appropriate space), point five ( 0.5 ) votes for Candidate C (she writes " 0.5 " in the appropriate space), and zero (0) votes for Candidate D (she writes in " 0 " in the appropriate space).
