Greetings from your home resort! We had a great 2017 and are delighted to report the events that shaped our year, as well as share upcoming initiatives for 2018.

Project Update

Last year we developed a 10-year plan to continue to upgrade your resort and stay on the course of upgrading your experience by building upon our past successes.

- In 2017 we opened "Fairway Terrace". The area includes three fire pits, gas lanterns, swings and piped in music. We have and will continue to host many outdoor activities in this communal area. Additional events in 2018 are planned in this area for families of all ages.
- In the fall four smoking gazebos were added in between the villa buildings. The dedicated gazebos are furnished with rocking chairs, tables and ash trays, as well as a ceiling fan and light for the evening hours.



- The Outdoor Resort Center Pool is currently under construction and once completed, we are confident you will enjoy the pool experience even more. One enhancement is the addition of a "zero entry", or sloped entry, which will make it easier for everyone to enter and exit the pool. The size of the pool will be expanded, providing additional seating and there will be fun water features for all ages. The whirlpool spa will be relocated to the left side of the pool, where the kiddy pool was previously located, and the whirlpool spa will be enlarged. I hope you are as excited about the changes as we are!
- We are also in the process of planning for the villa renovation due to take place in 2020. This 20-year renovation will include other updates in the Resort Center. This project will begin in January 2020 and will be completed in the spring of that same year. One villa building will be closed at a time and there will be minimal impact on your resort experience.

2018 marks my third year as your General Manager and I am pleased to have met so many Owners. Many of the resort improvements have been made based on your feedback. I encourage you to continue to complete your Guest Satisfaction Survey after each vacation and sharing your comments and suggestions to help us improve your resort experience.
